Introduction

Condition 17 of its licence requires Fulcrum Electricity Assets Ltd, to provide a Metering Point Administration Service (MPAS).

The charges listed in this statement have been constructed in a way, which reflects the requirements of Standard Condition 18 of our Distribution Licence.

All prices quoted in this document exclude VAT.

A report will be produced on a monthly basis advising the Supplier of those MPANs for which they are registered as the Supplier where the registration requires to be completed.

Entitlement to Use

MPAS services as defined in Distribution Licence Condition 18 include the maintenance of a register of technical and other data that is necessary to facilitate the supply of electricity by any electricity supplier to premises connected to our electricity distribution system. FEAL will provide this data to Suppliers and/or their agents, any person identified in the Balancing and Settlements Code and any person identified in the Master Registration Agreement as being entitled to receive such data.

The applicant will be required to be a signatory to the Master Registration Agreement (MRA) for the provision of registration services.

In accordance with Licence Condition 37, MPAS are provided under the Master Registration Agreement. Users should contact MRASCo if they wish to become a party to this agreement.

MRASCo has been established to manage accession to the MRA. Parties wishing to use these services should contact:

We will require the applicant to enter into an agreement with FEAL for the use of our MPAS service. The agreement will formalise the obligations between both parties, such as communication of information, levels of service and invoicing arrangements.

Where an agreement cannot be reached either party may request settlement by the Gas and Electricity Markets Authority.

MPAS Charges

MPAS charges recover the costs associated with information technology and the resources required to provide this service and are recovered in our Use of System Charges (as advised within our Licence Condition 14 Statement). Additional MPAS activities, not stated, in the charges for MPAS (see table on page 5), are to be charged on a transactional basis, at the request of the electricity Supplier, in accordance with Schedule 8 of the MRA.
